His areas of practice spanned league and team rights negotiations (exceeding 100 such agreements), rights exploitation strategy, intellectual property and data sharing matters, sponsorship, advertising, and marketing agreements, streaming platform product launches (including direct-to-consumer), and network naming rights, among others.

Phillip's legal acumen is complemented by his strong leadership skills and his ability to navigate complex legal landscapes. He has been recognized for his contributions to the industry and his commitment to excellence in legal practice.
